NOTIFICATION

Hon'ble the High Court of Tripura has been pleased to make the following guidelines for the purpose of extending protocol courtesies to the Hon'ble former Chief Justices of India, Hon'ble former Judges of the Supreme Court of India and Hon'ble former Chief Justices and Hon'ble former Judges of the High Court of Tripura and other High Courts of India.

A. Protocol facilities to be extended to the Hon'ble former Chief Justices of India:

1. Befitting protocol services shall be extended to their Lordships Hon'ble the former Chief Justices of India during their Lordships' visit to Tripura.
2. Whenever any Hon'ble former Chief Justice of India would visit Tripura, the Registrar General of the High Court shall receive and see off His Lordship at the Airport/Railway Station and His Lordship will be provided with a High Court vehicle and all other protocol assistance as per order of Hon'ble the Chief Justice of this High Court during His Lordship's stay in the State. The Protocol Officers of the High Court shall also liaise with the State Government to make the visit of His Lordship comfortable.

B. Protocol facilities to be extended to the Hon'ble former Judges of the Hon'ble Supreme Court of India :

1. Whenever any Hon'ble former Judge of the Hon'ble Supreme Court of India would visit Tripura, the Joint Registrar/Deputy Registrar (Protocol) of the High Court shall receive and see off His Lordship at the Airport/Railway Station.
2. On receipt of the tour programme of their Lordships, the Protocol wing of this High Court shall take up the matter with the State Government for providing conveyance, lodging and security to their Lordships as admissible under the rules of the State Government during their Lordships' stay in the State and the Protocol Officers of this High Court shall keep liaison with the State Govt. in this regard.
3. If it is so required, a High Court vehicle shall be provided to their Lordships for travelling within the limits of Agartala city. For travelling beyond Agartala, High Court on request will arrange requisitioned vehicle on payment basis.

4. Protocol facilities, in addition to above, may be extended to the Hon'ble visiting former Judges of the Hon'ble Supreme Court of India, as may be desired and approved in writing by the Hon'ble Chief Justice of this High Court.

C. Protocol facilities to be extended to the Hon'ble former Chief Justices and former Judges of the other High Courts :

1. On receipt of the tour programme of Hon'ble former Chief Justices and former Judges of the other High Courts, the same will be communicated to the State Government from the Protocol Section of this High Court for providing to their Lordships accommodation and conveyance on payment basis unless their Lordships are treated as State Guests/Govt. Guests by the State Government. A Protocol Officer of the High Court shall be deployed at the Airport/Railway Station to provide required assistance at the Airport/Railway Station during their Lordships' arrival and departure.

2. Protocol facilities, in addition to above, may be extended to the Hon'ble visiting former Chief Justices and Hon'ble former Judges of other High Courts, as may be desired and approved in writing by the Hon'ble Chief Justice of this High Court.

3. Apart from above, protocol facilities to the Hon'ble visiting former Chief Justices and Hon'ble former Judges of other High Courts shall be extended on reciprocal basis.

D. Protocol facilities to be extended to the Hon'ble former Chief Justices and Hon'ble former Judges of this High Court :

1. The tour programme of the Hon'ble former Chief Justices and Hon'ble former Judges of this High Court, as and when received, shall be forwarded to the Tripura Bhawans available outside the State and where there is no Tripura Bhawan to the Registrar General of the concerned High Court with a request to provide their Lordships accommodation and conveyance on payment basis and also to provide other protocol assistance as admissible to their Lordships in the concerned State during their Lordships' visit to such State.

2. Hon'ble former Chief Justices of this High Court shall be received and seen off at the Airport or Railway Station, as the case may be, by a Protocol Officer of this High Court in a befitting manner and their Lordships will be provided with a car from the High Court during their Lordships' stay in the State.

3. In case of Hon'ble former Judges of this High Court, a requisitioned vehicle, on payment basis, if so requested, shall be provided to the Hon'ble former Judges of this High Court for their Lordships' conveyance from the place of stay of their Lordships to Airport/Railway Station during their Lordships' departure from

Agartala and same facility shall be provided to their Lordships during their Lordships' arrival.

4. One protocol staff will be deployed at the Airport/Railway Station to provide their Lordships required assistance at the Airport/Railway Station during their Lordships' arrival and departure.

E. This is issued with immediate effect in partial modification of earlier Notification No.F.15(1)-HC/13-17/3655 dated 15.02.2017.
