NOTIFICATION

Hon'ble the Chief Justice has been pleased to order that henceforth, all the Family Courts & other Courts functioning within the jurisdiction of this High Court shall strictly follow the following guidelines:

01. All Family Courts shall record evidence of witnesses in Desk Top Computer/ Laptop in all cases and furnish copy of the depositions of witnesses recorded in divorce proceedings and maintenance proceedings free of cost to the parties on the date of recording of such evidence.
02. The District Judges and Addl. District Judges trying divorce cases and the Judicial Magistrates hearing maintenance cases, where there is no Family Court, shall also follow the same practice.
03. All Courts including Family Courts giving interim maintenance / monetary relief in any proceedings including proceedings in maintenance cases and cases under Protection of Women from Domestic Violence Act shall furnish copy of the order providing such interim maintenance / monetary relief to the petitioner and the opposite party free of cost on the date on which such order is passed.
