NOTIFICATION

The Hon'ble High Court has been pleased to notify the vacancies in all Grades of Tripura Judicial Service as on 31.12.2018 in terms of the order dated 04.01.2007 of the Hon'ble Supreme Court of India passed in Civil Appeal No.1867 of 2006 with Nos. 1868-72 of 2006 (*Malik Mazhar Sultan (3) and another Vrs. Uttar Pradesh Public Service Commission and others*) as follows:

1.	GRADE – I (Cadre of District Judge) Sanctioned strength 35 including 3 Deputation/ Leave Reserve posts

	<p>Call letters have been issued to the candidates for appearing in the Written examination to be held on 02.02.2019 & 03.02.2019 for filling up the vacancies in Grade-I by direct recruitment.</p> <p>As regards filling up of vacancies by promotion, only 01 Officer has completed the requisite qualifying service of 05 years in Grade-II to become eligible for promotion to Grade-I. Process has been initiated for consideration of his case for promotion to Grade-I.</p> <p>There is no other eligible officer in Grade-II having the qualifying service of 05 years in the Grade to become eligible for promotion for filling up the vacancies in Grade-I through limited departmental competitive examination or by regular promotion.</p>	

	It needs to be mentioned here that among the 35 sanctioned posts in Grade-I, 01 post has been sanctioned in September, 2018 and 04 posts have been sanctioned in November, 2018 by the State Government.

c)	Vacancies arising due to deputation of Judicial Officers to other department may be considered as temporary vacancy	0
2.	GRADE-II (Cadre of Civil Judge, Senior Division) sanctioned strength 35 including 6 Deputation/Leave Reserve posts	
a)	Existing vacancies Among the 08 vacancies, 07 vacancies have arisen due to creation of 07 new posts in the Grade. The State Government has sanctioned these posts in July, 2018. As per Tripura Judicial Service Rules, 2003 the vacancies in Grade-II are filled up by promotion of the eligible officers from Grade-III. At present there is no eligible officer having the qualifying service of 05 years in Grade-III for promotion to Grade-II.	08
b)	Future vacancies that may arise within one year due to retirement & promotion	Retirement- 00 Promotion- 06 06
3.	GRADE-III (Cadre of Civil Judge, Junior Division) Sanctioned strength 49 including 11 Deputation/Leave Reserve posts	
a)	Existing vacancies The High Court has issued advertisement on 30.11.2018 inviting applications for filling up 06 vacancies and Tripura Public Service Commission has issued advertisement on 27.12.2018 for filling up the rest 06 vacancies as per Tripura Judicial Service Rules, 2003.	12

b)	Future vacancies that may arise within one year due to retirement & promotion	Retirement – Nil Promotion - 12
