SPECIFICATION OF WINTER LIVERIES.

1. Long Coat (not Achkan) reaching up to 4" above the knee in scarlet red felt with Navy Blue sleeves and Navy Blue front.
2. One Navy Blue slacks without bottom fold.
3. The pattern of waist belt and sleeves of the Coat will be as under.

FOR JAMADAR.

Five inches wide waist belt with four golden lace stripes on Navy Blue background. They will have sloping stripes (seven) on each sleeves of the long coat (outside) on navy blue background. The navy blue slacks will have thin red stripes running from top to bottom of the outer side along the seam.

FOR ORDERLIES.

Four inches waist belt on navy blue background with three golden lace stripes. They will have three straight stripes on the golden lace on each sleeve on the long coat.

FOR BARKANDAZ / DRIVERS.

As above.

FOR DUFTRIES.

Three inches waist belt with two golden stripes on each sleeves on long coat.

FOR PEONS / GROUP-D / DRWs.

Three inches waist belt with a single stripes round the sleeves. Woolen cardigan for lady staff.

FOR MALIES.

Full sleeve navy blue Jacket and full navy blue pant.

FOR SWEEPER.

As above.
