**NOTIFICATION**

In exercise of the powers conferred by Sub-section (1) of Section 67 of the Central Motor Vehicle Act, 1988 and in supersession of the notification No.F.28(1)-Trans/2004(L) dated 4<sup>th</sup> August 2010 the Governor is pleased to direct the State Transport Authority to re-fix the rate of fare for the Stage Carriage (Ordinary Bus Service, Express Bus Service, Mini Bus Service, City Bus Service), Public Carriage (Goods Transport) and Contract Carriage (Jeeps, Taxis, Cars, Maruti Omni & Auto Rickshaw) etc. within the State of Tripura w.e.f. 9<sup>th</sup> November, 2012 at the rate and in the manner as stated in the schedules 'A', 'B', 'C' and 'D' below:-

**SCHEDULE- A**  
**(STAGE CARRIAGE - PASSENGER, BUS SERVICE)**

The fare for stage carriage, **Ordinary Bus Service** should be fixed @ 48.36 (forty eight point thirty six) paise per kilometer per passenger. The fare for **Express Bus Service** should be fixed @ 54.78 (fifty four point seventy eight) paise per kilometer per passenger and fare for **Deluxe Bus Service** should be fixed @ 83.20 (eighty three point twenty) paise per kilometer per passenger.

The fare for **Mini Bus Service** should be fixed @ 59.74 (fifty nine point seventy four) paise per passenger per kilometer.

*Note :- In schedule A above all fare rates are in terms of paisa only.*

The fare for City Bus Service ( Non-AC Bus / AC Bus) should be fixed per passenger as under :-

i.	Up to 4 K.M.	Rs.6.00 (rupees six) only	Rs. 10.00 (rupees ten ) only

iii.	8 to 14 K.M.	Rs.9.00 (rupees nine) only	Rs. 14.00 (rupees fourteen) only
iv.	14 to 19 K.M.	Rs.10.00 (rupees ten) only	Rs. 16.00 (rupees sixteen ) only
v.	19 to 26K.M.	Rs.11.00 (rupees eleven) only	Rs. 17.00 (rupees seventeen) only
vi.	Above 26 K.M.	Rs.12.00 (rupees twelve) only	Rs. 20.00 (rupees twenty) only

**SCHEDULE- B**  
**(PUBLIC CARRIAGE - GOODS TRANSPORT)**

The rate of freight of Public Carrier (Goods Transport) should be fixed @ 39.87 (thirty nine point eighty seven) paise only per quintal per kilometer (applicable for the distance from loading point to unloading point).

Note :- In schedule B above the freight rate is in terms of paise only.

**SCHEDULE- C**  
**( CONTRACT CARRIAGE )**

✓ (a) The rate for contract carriages, LMV (Diesel) should be fixed @ Rs.8.83 (rupees eight and eighty three paise) only per kilometer for full capacity.

Or

Rs.883.00 (rupees eight hundred and eighty three) only per day or part thereof.

Whichever is higher

Where Night Halt is involved - Rs.115.00 (rupees one hundred fifteen) only per night.

✓ (b) The rate for contract carriage - Ambassador (Petrol) should be fixed @ Rs.9.20 (rupees nine and twenty paise) only per kilometer for full capacity.

Or

Rs. 920.00 (rupees nine hundred and twenty) only per day or part thereof

Whichever is higher

Where Night Halt is involved - Rs.118.00 (rupees one hundred and eighteen) only per night.

✓ (c) The rate for contract carriage - Omni / Maruti or any other LMV (Petrol) should be fixed @ Rs. 7.21 (rupees seven and twenty one paise) only per kilometer for full capacity.

Or

Rs.721.00 (rupees seven hundred and twenty one) only per day or part thereof.

Whichever is higher

Where Night Halt is involved - Rs.118.00 (rupees one hundred and eighteen) only per night.

d) The rate for contract carriage – Auto Rickshaw ( Petrol / Diesel ) should be fixed @ Rs. 6.00 (rupees six) only per kilometer for full capacity.

(e) The rate for contract carriage – Auto Rickshaw ( CNG ) should be fixed @ Rs. 5.50 (rupees five & fifty paise) only per kilometer for full capacity.

### SCHEDULE -D

Rate of hiring charge of Ordinary Bus/ Deluxe Bus/ Mini Bus/ Truck on daily and kilometer basis should be fixed as follows :-

a) Ordinary Bus:-

Rs. 2241.00 (rupees one thousand eight hundred sixty eight) only per day or part thereof.

Or

Rs. 22.41 (rupees twenty two and forty one) only per kilometer for full capacity.

Whichever is higher

Where Night Halt is involved – Rs.373.00 (rupees three hundred and seventy three) only per night.

b) Deluxe Bus :-

Rs. 2545.00 (rupees two thousand five hundred and forty five) only per day or part thereof.

Or

Rs. 25.45 (rupees twenty five and forty five paise) only per kilometer for full capacity.

Whichever is higher

Where Night Halt is Involved – Rs.499.00 (rupees four hundred and ninety nine) only per night.

c) Mini Bus :-

Rs.1510.00 (rupees one thousand five hundred and ten) only per day or part thereof.

Or

Rs. 15.10 (rupees fifteen and ten paise) only per kilometer for full capacity.

Whichever is higher

Where Night Halt is Involved – Rs.316.00 (rupees three hundred and sixteen) only per night.

d) Truck:-

Rs. 1779.00 (rupees one thousand seven hundred and seventy nine) only per day or part thereof.

Or

Rs. 17.79 (rupees seventeen and seventy nine paise) only per kilometer for full capacity.


Whichever is higher

Where Night Halt is involved ~ Rs.218.00 (rupees two hundred and eighteen) only per night.

Stage wise fare of all the routes for all stage carriers will be fixed by Joint Transport Commissioner, Agartala, West Tripura. While fixing stage-wise fare, fractions in paisa may be rounded off to the next rupee

The rate fixed above may be treated as maximum rate.
