**NOTIFICATION**

In exercise of the power conferred under sub rule(3) of Rule108 of Central Motor Vehicles Rules, 1989 and in compliance with the directions dated December 10,2013 issued by the Supreme Court of India in Special Writ Petition No.(C) 25237/2010 and Special Leave Petition No.23984/2010, the Governor of Tripura has been pleased to notify the persons who are authorized to use red light with flasher only, red light, and blue /amber light without flasher on their vehicles while on duty. The red light/ blue/amber light may be used on the top front of vehicle.

**II. Dignitaries/Officials authorized to use Red Light without flasher:**

1. Chief Minister.
2. Chief Justice, High Court.
3. Speaker, TLA.
4. Cabinet Ministers.
5. Leader of Opposition, TLA.
6. Vice Chairman, State Planning Board.
7. Judges of High Court.
8. Ministers of State / Deputy Ministers.
9. Deputy Speaker, TLA.
10. Advocate General, Tripura.
11. Chief Secretary, Tripura.
12. Director General of Police.
13. Chairman/ Chief Executive Member, TTAADC.
14. Executive Members, TTAADC.

**III. Officials/Vehicles authorized to use Blue or amber lights:**

1. Ambulances carrying patient(s),
2. Fire Tenders used by Fire and Emergency Services Department,
3. Vehicles used by Disaster Management Department for rescue operation.
4. Rescue vans of Civil Defence Department.



5. Vehicles used for law and order duties and/or as escorts or pilots.

In case such vehicle is not carrying the dignitaries, the red light shall not be used and be covered by a black cover.


